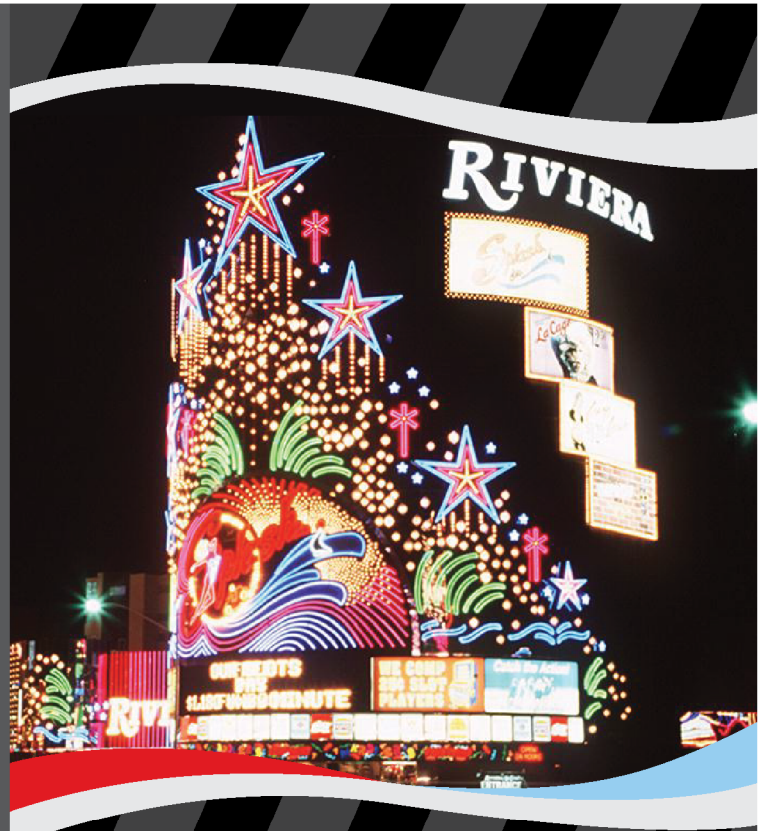

TERMS & CONDITIONS

- 1 This certificate is valid for two nights of accommodations in one room for up to two adults in Las Vegas at the Riviera Hotel & Casino.
- 2 To register, you must fully complete this certificate and mail it to Casablanca Express (CBE) prior to the registration deadline.
- 3 Upon registration, you will receive a reservation letter with a toll-free telephone number to call and request your arrival date. Accommodations must be utilized within one year of the date your reservation letter is issued.
- 4 All reservation requests are subject to availability and must be made by calling the toll-free telephone number on your reservation letter. All requested arrival dates are subject to availability and must be made at least 30 days in advance of that date. You must choose a Sunday, Monday, Tuesday or Wednesday arrival date. This certificate is serviced by Casablanca Express, do not contact the Riviera Hotel directly for reservations. **The Riviera Hotel does not endorse and will not honor this certificate.**
- 5 After you arrange an arrival date you will receive a confirmation letter with your assigned date advising you of the deadline for payment of a tax deposit for hotel occupancy taxes. Your arrival date will not be deemed confirmed unless CBE receives your signed confirmation letter with the required hotel occupancy tax deposit by the deadline. Once an arrival date is assigned there are no changes or reschedules allowed.
- 6 This certificate does not include air or land transportation, transfers, meals, taxes, energy surcharge, or any incidental expenses such as phone calls, gratuities or entertainment. Hotel may require a credit card imprint or deposit upon check-in to cover incidental expenses.
- 7 Hotel occupancy taxes (approx. \$7 to \$15) are the sole responsibility of the Certificate Holder. Taxes will not exceed \$15 total. Excess tax deposit, if any, will be refunded by check prior to your arrival date.
- 8 Until CBE purchases your accommodations, you may cancel and receive a full refund of your tax deposit. A personal CBE representative will contact you to finalize the details of your trip before purchases are made. If you cancel at any time, this certificate will be deemed void. Your travel documents will be mailed to you at least 10 days before your arrival date. Failure to update your address and telephone numbers will prevent your receipt of your travel documents.
